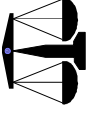

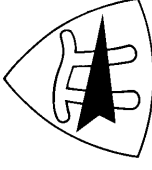

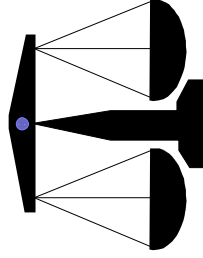
Employee Rights
